**Mrs Funmilayo Ikuomola – appointed by foundation body or sponsor**

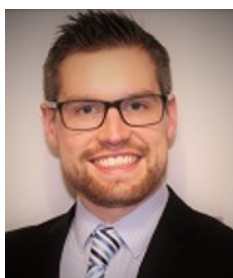
Appointed: 7 October 2021
